<b>OVERVIEW</b> Creates a single national health insurance program, administered by the federal government, for all US residents.	<b>OVERVIEW</b> Federal public plan option offered to eligible individuals; would compete with other private insurance plans	<b>OVERVIEW</b> Provides an option for individuals to buy into Medicare	<b>OVERVIEW</b> Provides an option for individuals to buy into a state's Medicaid program
<b>PROVIDER PAYMENTS</b> Typically fee-for-service (FFS)	<b>PROVIDER PAYMENTS</b> Typically FFS-would not fall below current Medicare payment rates	<b>PROVIDER PAYMENTS</b> Follows Medicare payment rates (FFS); Medicare participating providers	<b>PROVIDER PAYMENTS</b> States required to pay primary care providers at least Medicare rates (FFS)
<b>PROVIDER PARTICIPATION</b> All state-licensed and certified providers	<b>PROVIDER PARTICIPATION</b> Medicare (and sometimes Medicaid) participating providers	<b>PROVIDER PARTICIPATION</b> Medicare participating providers	<b>PROVIDER PARTICIPATION</b> Medicaid providers, including Medicaid managed care organizations
